#### Documents and Items Required:

1. Completed Visa Application Form
2. Copy of Completed Visa Application Form
3. Original Passport (with at least Six Months Validity)
4. 2 Copies of passport (Particulars Pages Only)
5. Form 2 (Invitation Letter)
6. 2 Passport Size Photos ( One Attached to the Application Form and one to its copy)
7. Original Bank Receipt for Visa fee.

#### Notes:

- a) An Interview might be necessary for some applicants.
- b) Visa Issuance time will be 7-14 Days.
- c) A Business Questionnaire (for commercial companies wishing to engage in business with their Iranian counterparts) will be required.
- d) A Letter from TDC for Participating in the Exhibitions in Iran.
